Project Title: "Women GBV survivors Leading the Change".

1. Project Description

The project aiming at empowering women survivors of violence to break the circle of violence and its consequences and support them to raise their voices loudly to stand against this violence and the social stereotypes and enable them to resume their life normally and act as positive deviants (change agents) in their communities. The project also addresses the lack of appropriate access to protection services due to the weak response and performance of the relevant service providers, the scarce resources and budget and weak infrastructure.

Project duration: 2 years (15 February 2022 - 15 February 2024)

Project location : West Bank.

2. Purpose of the Evaluation

The Evaluation is intended to assess the relevance, performance, management arrangements and success of the project. It looks at signs of potential impact of project activities on social behaviors, attitudes towards women GBV survivors, the relevant laws and legislation, and wider community perceptions and perspectives, and will look into sustainability of results, including the contribution to capacity development. The Evaluation also identifies/documents lessons learned and makes recommendations that project partners and stakeholders might use to improve the design and implementation of other related projects and programs.

3. Scope of the Evaluation

The evaluation is expected to cover the following project expected outcomes:

- Outcome 1: Build the 30 Women GBV survivors (Positive Deviance) capabilities and awareness to inspire and support other WGBV survivors, lead advocacy actions to demand fairer, just, improved and accessible services and adequate budgets at local& national level.
- Outcome 2: The Women survivors of violence implemented advocacy and awareness campaigns for local communities, covering all levels and ages, to eliminate gender-based violence and create a supportive environment for women.

- Outcome 3: The Capacity of targeted service providers (police, ministry of social development, shelters staff, health, relevant law enforcement personnel) to respond adequately to VAW cases have increased and improved.

This evaluation has the following principal tasks:

1. Assess the project design in terms of its relevance to the overall women protection at the national level; relevance to national strategies, laws and attitudes, and relevance to beneficiaries;
2. Assess the cost-efficiency of project interventions;
3. Assess the project impact on women survivors of violence, protection, accessibility to services, capacity building, social attitude and perceptions and relevant stakeholders' response and actions.
4. Assess relevance and effectiveness of the project's strategy and approaches for the achievement of the project objectives;
5. Assess performance of the project in terms of effectiveness, efficiency, and timeliness of producing the expected outputs;
6. Assess the quality and timeliness of inputs, the reporting and monitoring system and extent to which these have been effective;
7. Assess relevance of the project's management arrangements; identify advantages, and lessons learn with regard to the management arrangements;
8. Analyse underlying factors beyond Women Media and Dvelopment -TAM control that affect the achievement of the project results;
9. Provide recommendations to key project stakeholders for follow-up activities;

4. Deliverables

The output of the mission will be the **Evaluation Report** in English. The structure and content of the report should meet the requirements of TAM. The length of the Report should not exceed 30 pages in total (excluding the annexes).

The Report should:

- Contain an executive summary
- Be analytical in nature (both quantitative and qualitative)
- Be structured around issues and related findings/lessons learnt
- Include conclusions
- Include recommendations

- Profound knowledge and experience in women's rights, gender and the national protection relevant laws, systems and policies with practical experience working with women victims of violence.
- Experience and knowledge in the field of outcome approach
- At least 5 years' experience in the field of NGO's project evaluation.
- Excellent writing skills in English.
- Fluency in English required.
